



MOBILE COUNTY REVENUE COMMISSION

BUSINESS PERSONAL PROPERTY TAX LEVY SALE

Pursuant to Alabama Code § 40-5-14, on Monday, January 24, 2022 at 10:00 A.M., the Mobile County Revenue Commission will conduct a Tax Levy Sale of business personal property belonging to Dawson Vessels, Inc., to collect payment of delinquent personal property taxes owed.* The tax levy sale will be held at 750 Viaduct Road, Chickasaw, Alabama 36611, in Mobile County, Alabama.

The following is subject to be sold at public auction to the highest bidder:

- BARGE, BILL JR (OFFICIAL VESSEL NO. 649210) INCLUDING ALL PARTS AND IMPROVEMENTS

Rules of the Tax Levy Sale:

1. The property will be sold to the highest bidder.
2. Any statutory expenses related to keeping and storing the property will be added to the highest bid and paid to the storage facility.
3. Payment must be made in cash or certified funds (e.g., cashier's check, certified check, money order). The property will not be released until payment is made in full.
4. The auction will begin at 10 AM on January 24, 2022.
5. The property will be sold as-is, where-is.
6. All sales are final.
7. Property sold is not subject to redemption.
8. Property sold must be picked up within 7 days after full payment is made. If the property is not moved by close of business on the day of the Tax Levy Sale, it may be subject to additional storage expenses.

* Please note that if the amounts owed are paid before this time, the Tax Levy Sale will be cancelled.
